



SV/SLV Soccer Club Waiver/Release and Assumption or Risk Agreement/Informed Consent

Inherent in participation in the Scotts Valley/San Lorenzo Valley Soccer Club programs and the related events and activities, whether as an athlete, a volunteer, a coach, an employee or a spectator, are certain hazards and dangers including possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death to all participants does exist; and information concerning COVID-19 and its transmission is still being acquired, with much that is currently unknown, with new information continuing to be obtained on a frequent basis.

_____ I understand that Santa Cruz County public health authorities, the California Department of Public Health, and the CDC provide safety protocols for youth sport participation. Participants and spectators will be required to follow any State and County **mandates/requirements**, which may include practicing social distancing, handwashing hygiene, quarantining, and use of face coverings; and that non-compliance may result in loss of privilege to participate;

_____ I understand that Scotts Valley/San Lorenzo Valley Soccer Club will follow County and State guidelines and will not impose requirements that exceed County and State mandates;

_____ I understand that the soccer program will be occurring in public locations. There is no assurance, and can be no assurance, that all information is known which would limit the risk of participation in the forgoing athletic programs and related events and activities;

_____ I accept and agree that as a participant (coach, volunteer, employees) or parent/guardian of a participating child to comply with all current and future modified procedures and protocols while participating in Scotts Valley/San Lorenzo Valley Soccer Club activities, and that non-compliance may result in loss of privilege to participate;

_____ I accept and agree as a participant (coach, volunteer, employee) or parent/guardian of a participating child to conduct pre-event health screening prior to each practice, game, or program events. I will withhold participation if a temperature higher than 100.5 degrees is determined or participant is experiencing any symptoms of illness such as cough, shortness of breath, difficulty breathing, fever, chills, muscle pain, headache, sore throat or any new loss of taste or smell;

_____ I accept and agree as a participant (coach, volunteer, employee) or parent/guardian of a participating child to withhold participation if exposed to someone that is suspect or has been confirmed to have the coronavirus/COVID-19 in accordance with County and State requirements;



_____ I accept and agree if as participant (coach, volunteer, employee) or parent/guardian of a participating child is diagnosed with coronavirus/ COVID-19 during the season, I will notify the coach and safety@svslvsoccerclub.org;

_____ I accept and agree that my registration contact information will be shared with County health officials if needed in the interest of public safety;

By agreeing and accepting this document, I hereby release and agree to hold Scotts Valley/San Lorenzo Valley Soccer Club along with their respective directors, officers, officials, employees, representatives, staff, volunteers, other participants, sponsoring agencies, and owners and lessors of premises used to conduct activities (collectively "RELEASEES ") harmless from and waive on behalf of myself, my heirs, and personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act, or that may otherwise arise in anyway in connection with any programs or activities of Scotts Valley/San Lorenzo Valley Soccer Club. EVEN IF ARISING FROM RELEASEES NEGLIGENCE, to the fullest extent provided by law.

I have carefully read this agreement, discussed expectations with my child and fully understand its contents. I understand that by accepting this agreement I have given up substantial rights as a participant or on behalf of the participant. I am fully informed as to its contents and have had adequate opportunity to read and review it.

I ACCEPT THIS AGREEMENT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT FOR PARTICIPANTS OF MINORITY AGE UNDER AGE 18 AT THE TIME OF REGISTRATION.
